SDC Deferral Program Portal Application Process

To apply for the SDC Deferral Program in Portal, please follow these step-by-step instructions during the Permit Application process:

- 1) Under the Permit Types, select the SDC Deferral Program option along with the other Permits that you will need.

- 2) On the Work Items page, near the bottom of the screen, there will be a section for the SDC Deferral Program Permit. Check the appropriate box for the work item: to defer Commercial SDC Deferral or Residential SDC Deferral. **Please note:** Parks SDCs can only be deferred for residential developments).

- 3) On the Description of Work page, near the bottom of the screen, there will be a section for the SDC Deferral Program Permit Work Item. The quantity of 1 will already be in this field. You do not need to do anything additional.

5) On the Review & Submit page, make sure that there is a Permit: Apply for SDC Deferral Program, and an entry for the SDC Deferral Application under Uploaded Documents. An administrative fee, if applicable, will be due as outlined in the current City of Bend fee schedule, and must be paid with the submission of the Application For System Development Charges (SDC) Deferral.

6) Complete and Submit your Permit Application. You will need to pay the SDC Deferral Application Fee, if applicable, and any other required permit fees prior to the start of the review process.

7) For commercial developments that are assessed Parks SDCs: these must be paid prior to permit issuance. Water, Sewer and Transportation SDCs can be deferred for these developments.

Once approved, the instructions for how to pay the deferred SDCs will be uploaded to your permit application.
