League of Oregon Cities Bulletin

- This week, Governor Kotek issued a [letter](#) to legislators signaling continued concerns from landowners on the most recent update to the wildfire hazard maps that went public on January 7. The governor's letter has effectively paused any deliberations on the appeals until after the legislative session.
- LOC is asking for testimony in support of infrastructure for housing. Governor Kotek's housing bill ([HB 3031](#)) would establish a new Housing Infrastructure program to fund water, sewer, stormwater, and transportation infrastructure linked to new housing development. A hearing is scheduled for February 26 at 1:00 pm.



- On February 24, the House Committee on Housing and Homelessness will hear [HB 3644](#) which is designed to create a programmatic approach at the state level for the funding of homeless shelters. HB 3644 creates a standardized regional approach for shelter funding.

Bend Chamber Feedback

We received feedback from the Bend Chamber following the January 14th Council and Advisory Body Summit (which a Leadership Bend member attended). They were impressed with how the Core Advisory Board advises on ways to improve BURA and the many aspects of the community they interact with; the work and effort that is poured into transportation projects; and they gave kudos to Russ Grayson, saying, “Every time we get to hear him speak, I become more amazed with how much he has on our plate. It's comforting from my standpoint to know someone with such gravitas is positioned to help the City in such a monumental way.”
