- Next week marks the beginning an accelerated effort from cities to prepare communications and advocacy support for the critical link that TRIP 2025 has to local governments. The LOC is requesting that cities prepare simple information that will include a top-line message about TRIP 2025, illustrating what the City has done with its share of the SHF in the local community.
- The American Rescue Plan Act (ARPA) reporting portal has opened for filing of the required annual or quarterly report. The deadline to file for all **State and Local Fiscal Recovery Fund (SLFRF)** grantees is April 30, 2025.
