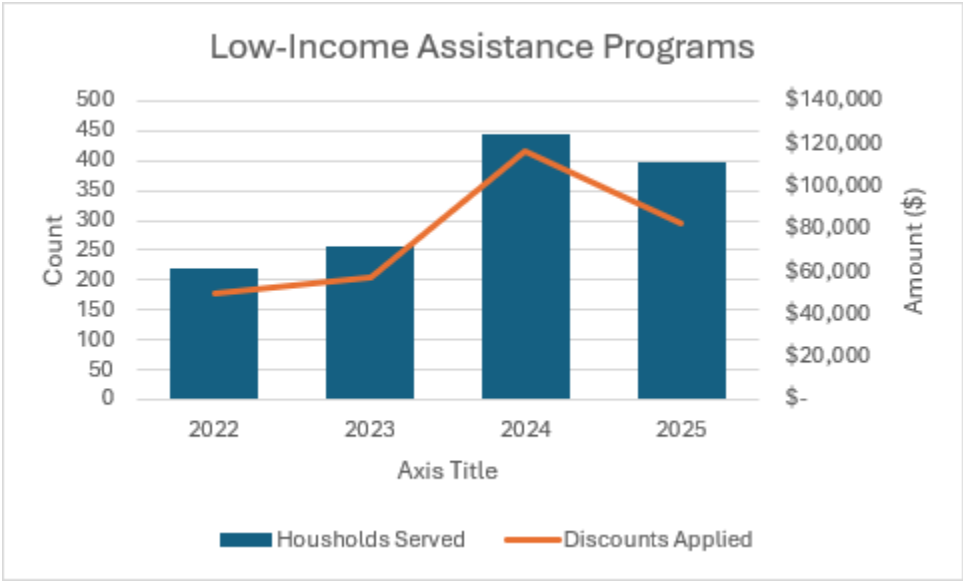

September Bend Buzz

Low-Income Assistance Program Update

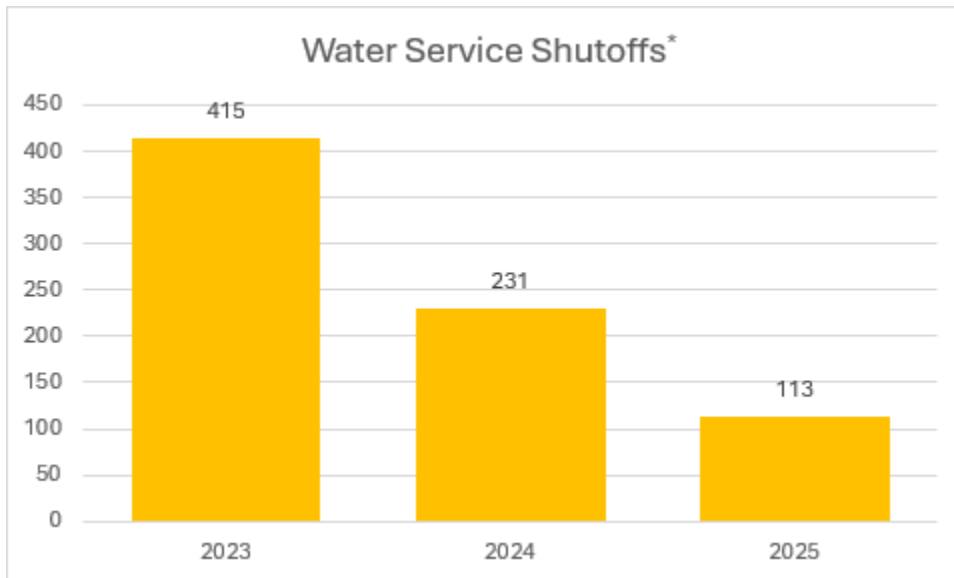
In October 2023, the Water Services Department launched the Low-Income Assistance Program, replacing legacy programs with a more inclusive one. The new program is open to all low-income households, with automatic eligibility to those receiving certain state or federal public assistance. It is administered in partnership with NeighborImpact, which provides professional support for enrollment, eligibility verification, and recertification. The graph below shows the number of households served and the total value of bill discounts applied from January 1, 2022 – August 31, 2025. Following the program update, enrollment and total assistance provided increased dramatically, reflecting the broader reach and improved accessibility of the new program. This year, expectations are to meet, or possibly exceed, the totals from 2024 by year-end.



In addition, water service shutoffs have declined significantly, driven by expanded outreach efforts. Staff directly engaged customers regarding available assistance programs, thus helping more households stay connected, access support, and avoid service disruptions. The chart below presents



shutoff data from January 1, 2023 – August 31, 2025. Shutoffs were suspended during the COVID-19 pandemic (March 2020–August 2022), resulting in no activity during that period. Based on the current monthly average of 14.1 shutoffs, the expectation is that total shutoffs will remain well below last year's figures.



2025 State of Housing and State of Economy Reports Published

The 2025 **State of Housing** and **State of Economy** reports are published in support of the Bend City Council's goals to advance housing production and economic prosperity based on community needs, while aligning with state and regional plans. Together, these reports provide a comprehensive overview of Bend's housing market and economic landscape, offering critical data to support the development of affordable and middle-income housing units, as well as business and wage growth strategies. Along with the **Industry Cluster Analysis**, they will inform the overall development of the City's Invest Bend Campaign which will produce the first economic development strategic plan and the Bend Urban Renewal Agency's Investment Strategy.

BEND AIRPORT RECIEVES FEDERAL FUNDING

Bend Municipal Airport is receiving a Federal Aviation Administration (FAA) funded award under the Airport Improvement Program in the amount of \$3,930,621. These improvements are part of the City of Bend's continued commitment to the safe and efficient operation of the third most active of 97 public use airports in the state of Oregon.
