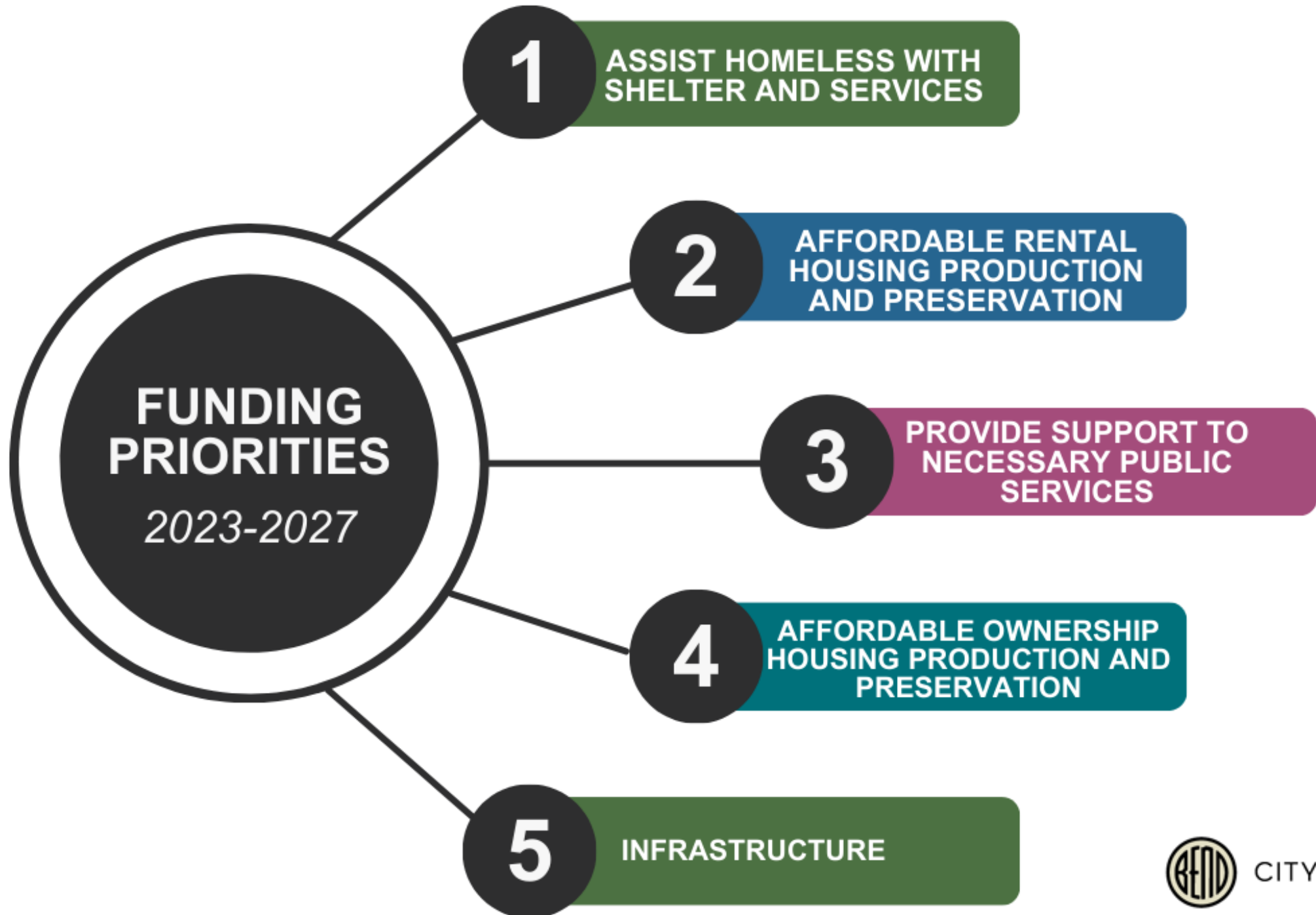

# Background on Amending an Annual Action Plan

---

- HUD requires an Annual Action Plan amendment whenever changes occur to the funding structure, amount, or potential recipients of CDBG funding.
- The process calls for a 30-day public comment period and public hearing.
- HUD approved the 2025 Annual Action Plan on September 15, 2025.
- On October 3, 2025, Volunteers in Medicine regretfully informed the City of Bend their decision to decline the funding award.
- The declined funds will now be evenly allocated to the public service projects of Saving Grace and Thrive Central Oregon.
