Oregon Business Plan Releases “Oregon at a Crossroads” Report

The **Oregon Business Plan**, an economic development organization that brings together leaders from business, government, and nonprofit sectors, has released a new report: ***Oregon at a Crossroads – How We Can Compete & Thrive.***

The report begins by examining changing demographics and population trends that are reshaping Oregon’s economy and workforce. It then discusses structural challenges in key systems—land use, regulatory frameworks, forest management, and education—that are not effectively meeting today’s needs.

To address these issues, the report calls for action to modernize outdated systems and position Oregon for long-term success. It emphasizes updating critical infrastructure and policies, accelerating site readiness for economic development, improving school performance, reducing wildfire risk, broadening the tax base over time, and strengthening Oregon’s ability to attract and develop talent. DEPARTMENT UPDATES

Private Development Fee Updates Effective January 1, 2026

Councilors, please read: **Memo to Council: Private Development Fee Update**

The Community Development Department (CDD) will implement modest fee adjustments starting January 1, 2026, as part of its ongoing revenue stabilization plan. Thanks to previous phased increases recommended by Bend Economic Development Advisory Board and approved by Council, CDD revenue has largely stabilized, resulting in a **smaller 2026 fee adjustment** than originally proposed.

Key updates:

- **Building Safety:** There will not be a need to implement the planned 10% increase on January 1, 2026.
- **Planning:** Recent recalibration has stabilized the Planning Fund sufficiently and eliminated the need for the scheduled 5% increase on January 1, 2026.
- **Private Development Engineering (PDE):** Staff reviewed 25 of the highest-volume Tier 1 and Tier 2 permits and identified nine as underpriced, creating projected shortfalls in the five-year financial model. To address this, a one-time fee adjustment averaging 5%—including a 3% across-the-board increase and targeted corrections—will be implemented.

Thanks to collaboration between the City and partners in the development community, the three fee-supported funds are approaching sustainable levels. Other than adopting the January 1, 2026 PDE fees



and recalibrating Tier 3 permits, the **City intends to end the phased fee increase program**. Going forward, Building Safety, Planning, and Engineering fees will be adjusted annually on July 1 to reflect cost escalation. Bend Municipal Airport Lighting Project Begins January 2026

Starting January 2026 through May 2026, Bend Municipal Airport will undergo a major capital improvement project. This work will require phased, temporary closures of the runway and taxiways to ensure safety during construction.

The improvements will address critical maintenance and modernization needs, including crack repairs and asphalt patching on Taxiways A and B, applying a seal coat over 75,000 square yards of pavement, and installing new LED Medium Intensity Taxiway Lighting (MITL) to replace outdated reflectors—adding approximately 25,000 linear feet of lighted edges. Additional updates include a runway number change from 16-34 to 17-35 to reflect magnetic variation adjustments, along with fresh painted runway numerals and updated lighted sign panels. - 3 elected officials
- 1 business community member
- 2 law enforcement representatives
- 1 person with lived experience
